

Oil Price Development






- Prices remain low

Raw Material Price Development: PP and LDPE






- Base Materials: PP Propylene LDPE Ethylene
- PP seasonal ups and downs not evident in the past year
- Balanced supply and demand
- Inevitable that prices will rise spring 2017 at the latest
- PE small increase in Ethylene contract price;
 producers looking to improve margins

PA 6


Base Materials:

PA 6 = Caprolactam, Benzene

- Continued increase in production of caprolactam in China
- Stable supply and pricing expected to continue

Raw Material Price Development: PA 66





PA 66


Base Materials:

PA 66 = 50 % Adipic Acid, 50 % HMD

- General price outlook remains stable
- Force Majeure INVISTA in Texas 22% of global market potentially facing availability issues

Base materials:

PA610: 60 % Sebacic Acid

40 % HMD


PA612: Butadiene

Limited number of suppliers keeping pricing stable

Development Raw Material Prices: PET and PBT





- Over capacity in both PET prime and bottle grades; short term pricing strategy
- PBT slight reduction in pricing over the past 12 months
 food grades remain in higher priced bracket
